## 4. First-aid measures

## 6. Accidental release measures

<b>Personal precautions, protective equipment and emergency procedures</b>	Keep unnecessary personnel away. Local authorities should be advised if significant spillages cannot be contained. <b>Methods and materials for containment and cleaning up</b>	Large Spills: ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Absorb in vermiculite, dry sand or earth or absorbent material then place into containers. Following product recovery, flush area with water.  Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.  Never return spills in original containers for re-use. For waste disposal, see section 13 of the SDS.
<b>Environmental precautions</b>	Prevent further leakage or spillage if safe to do so. Prevent entry into waterways, sewer, basements or confined areas. Avoid discharge to the aquatic environment. Contact local authorities in case of spillage to drain/aquatic environment. Avoid discharge into drains, water courses or onto the ground.
